



## Release and Waiver of Liability.

This Release and Waiver of Liability (The "Release") is executed by the undersigned (The "Participant"), and Granby Arts LLC, The Dragonfly Art Studio, Dragonfly Art Camp, and its affiliates members, managers and employees (collectively referred to as "The Dragonfly Art Studio") with regard to classes, activities, workshops, and other events held at The Dragonfly Art Studio, and attended by Participant, and/or Participant's minor children, and/or minor children under direct supervision of Participant, and/or minor children who are participating individually with permission of a parent/guardian (collectively referred to as "Participant").

The Participant does hereby freely, voluntarily, and without duress execute this Release under the following terms:

### **1. Waiver and Release:**

Participant does hereby release and forever discharge and hold harmless The Dragonfly Art Studio, Dragonfly Art Camp, its successors and assigns, employees, instructors, and associated personnel from any and all liability claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participants, and/or participant's minor children's, involvement in activities hosted, organized or involving The Dragonfly Art Studio. Participant understands and acknowledges that this Release discharges The Dragonfly Art Studio, from any liability or claim that the Participant may have against The Dragonfly Art Studio with respect to any accident, bodily injury, personal injury, illness, or property damage or loss that may result from Participants involvement.

### **2. Assumption of the Risk:**

Participant recognizes and understands that there may be inherent risk with regard to Participant's involvement. Participant understands and acknowledges that this Release discharges The Dragonfly Art Studio from injury, illness, accident, or property damage or loss resulting from participation in any event associated with The Dragonfly Art Studio.

### **3. Insurance:**

The Participant understands that insurance for liability, health, and medical or disability coverage in any way related to this event and under this agreement is the sole responsibility of Participant.

**4. Indemnification:**

Participant agrees that he/she will indemnify and hold The Dragonfly Art Studio harmless from any liability resulting from involvement in this event by Participant, his / her assigns, heirs, guests, invites or other persons accompanying Participant.

**5. Media Consent**

Programs at The Dragonfly Art Studio are occasionally photographed or recorded by video. Enrolling in a program, registering for an event, or otherwise participating in any activity at The Dragonfly Art Studio authorizes us to have, use, publish, and reproduce photographs, video, and any other representation of you, of minor family members who participate, and/or of your artwork or projects, for promotional, marketing, and public relations purposes in print, digital, or other medium. Please contact us if you are opposed to the above policy.

**5. Other:**

Participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by laws of the State of Virginia and that this Release shall be governed by and interpreted in accordance with the laws of the State of Virginia. Participant agrees that in the event that any clause or provision is determined to be or to have become invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions of the contract shall not in any way be affected or impaired.
